### 5. **Director's Report**

The Director reported on the following:

1. We have been notified the District is eligible to receive SRF bypass loan money from IEPA for our Sugar Creek CSO Headworks Project. This is the previously bid project which came in above estimate. We were unable to rebid it due to IEPA not providing funding in their next fiscal year. We will be rebidding the project in April and the project is expected to cost approximately \$9M.

2. Construction is progressing on the Bunn Park Project with storm sewer now being installed and the pavement will take work as weather allows.

3. The District began participating in the Illinois Wastewater Surveillance program for Covid testing of our plant flows for each plant and are awaiting results to show up on the website.

4. We have submitted the Oak Ridge CSO Project to IEPA for permitting and will bid the project later this year when all permits are in place.

5. We have signed and submitted our grant agreement for our DCEO Grant. We are waiting for the executed copy to be returned once DCEO signs.

#### 6. **Attorney's Report**

a. Personnel

Joe Roesch, District Attorney, reported the Union requested a Stage III grievance hearing. This step elevates an employee grievance to the Board. The Board designated Attorney Roesch as the Boards Hearing Officer to perform this task on behalf of the Board. All members present concurred with this plan. The Union will be contacted, and a hearing date will be set.
